## History of GSPA

The Graduate School of Public Administration (GSPA), founded in 1959, is the first professional graduate school in Korea. Since then, GSPA has been committed to empowering students to become experts that successfully apply their knowledge and skills in responding to public issues. It has become one of the top leading educational institutions in Asia through a world-class research and educational infrastructure, networks with developing countries and various practical training programs.

- **January 1959:** Graduate School of Public Administration is established on a Presidential Decree
- **March 1961:** First Master's Degrees of Public Administration delivered to 80 graduates
- **December 1962:** The first issue of Korean Journal of Public Administration is published
- **July 1971:** The nation's first executive non-degree program (ACAD, Advanced Center for Administrative Development) is founded
- **1976:** The nation's first doctorate program in public administration is launched
- **1981:** Public policy major is added to the master's program
- **2010:** Master of Public Enterprise Policy degree program and Public Executive Leadership non-degree program are launched
- **2011:** Global Master of Public Administration is founded in cooperation with KOICA (Korea International Cooperation Agency)
- **2014:** Joint MPA program for Korean public officials are added to the GMPA program

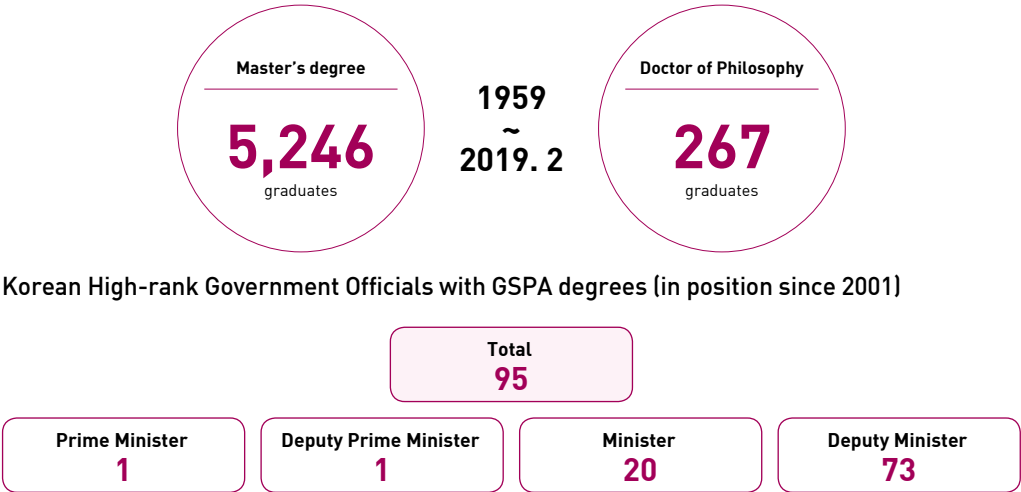

#### BK21 Plus

The Graduate School of Public Administration of Seoul National University has participated in the BK21 Plus Project (Brain Korea 21 Program for Leading Universities & Students) since 2013. #### GSPA Student Internship Program

Since 2009, GSPA has been operating a student internship program to offer career development opportunities to GSPA students. #### Public Officer Preparation Track

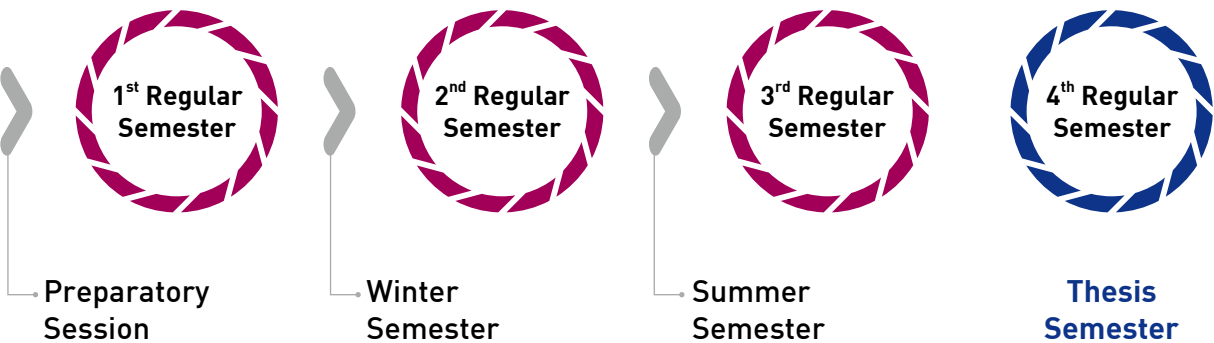

### Objectives

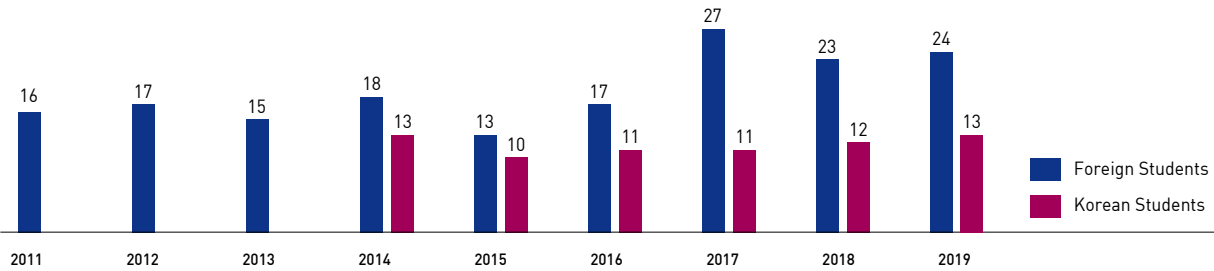
- To foster global leaders with cultural intelligence and professional analytical capability in public affairs and policy by training public officials from developing countries.

### Program Overview

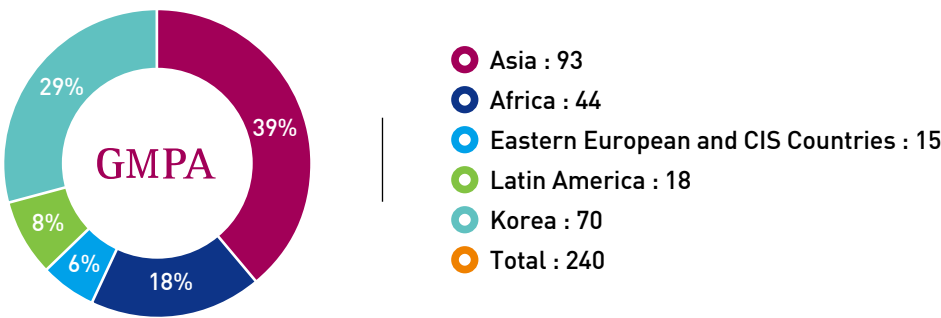
- Launched in September 2011 with a combined effort of SNU GSPA and KOICA
- Eligible for international and korean public officials as well as ordinary students holding BA degree.
- Four semesters for earning degree including 17 months of study in Korea (for KOICA Scholarship student)
- Admission of 25 public officials from developing countries offering a full scholarship including stipend, 10 to 15 public officials from the Korean government, and a few general students who are interested in public policy and administration (Approximately)
- Master in Public Administration (MPA) degree is awarded.
- Korean public officials are eligible for dual degrees after completion of requirements of both GMPA and partnership universities.
- Eligible to internship at the Korean government, research institutes, and other public organizations.



### GMPA Students Profile



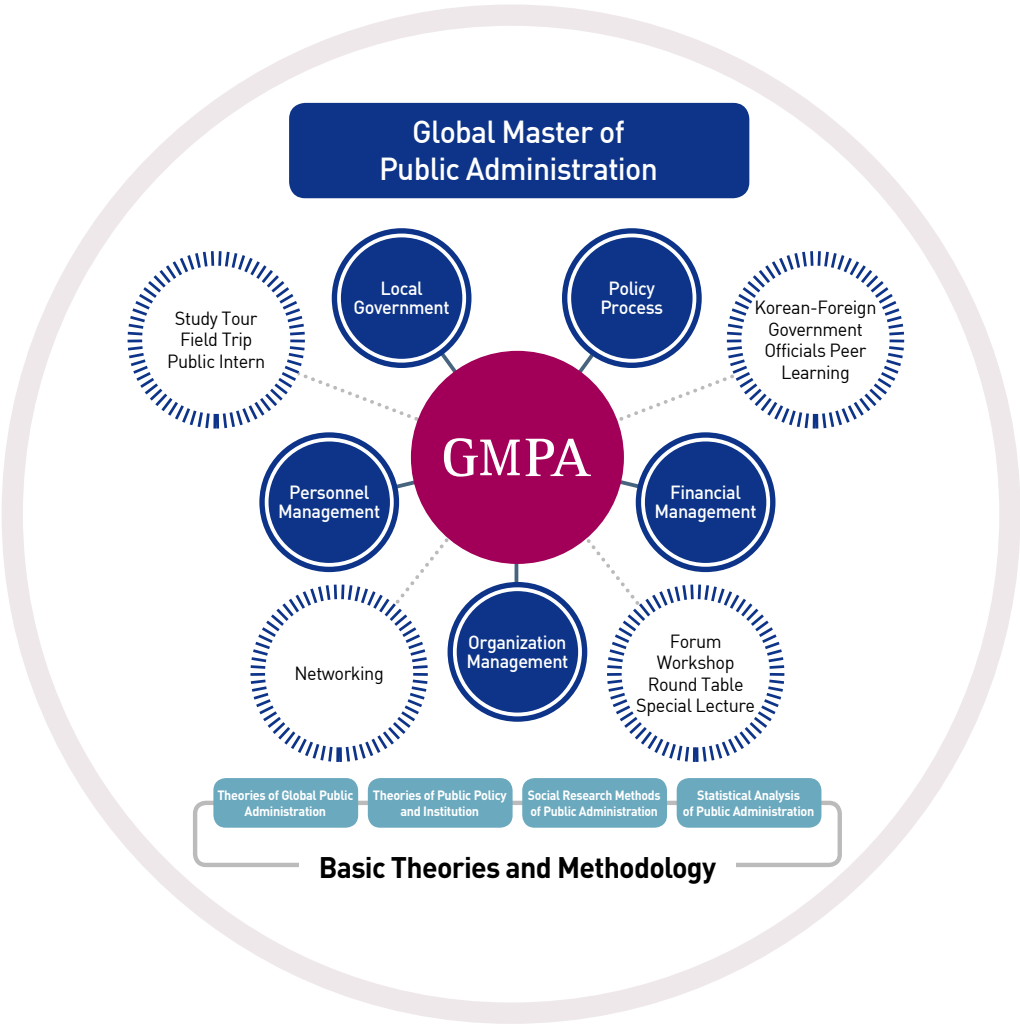
### Students by Region





# GMPA Program

The Global Master of Public Administration program consists of 6 modules curriculum and 4 modules special activities. The 10 modules have been designed to deliver the academic contents in systematic and in-depth manner as follows.



- Students will be required to study 33 credits including 27 credits for elective modules, and submit their master’s thesis, and pass the final thesis examination.
- Students recommended by the Korean Government continue their study in one of our collaborating universities\*\*.

## SNU-KOICA Partnership and Scholarship Program

The Korea International Cooperation Agency (KOICA) was founded as a government agency on April 1, 1991, to maximize the effectiveness of Korea's grant aid programs for developing countries by implementing the government's grant aid and technical cooperation programs.

Human Resource Development (HRD) had been considered as one of the most important factors in the Korea's escape from the vicious cycle of poverty and underdevelopment which had existed for many decades after the Korean war. With its scarce natural resources, HRD played a vital role in Korea's development; thus, Korea has emerged as an exemplary showcase of national development powered by HRD. With much extensive experience and know-how in HRD, Korea has contributed greatly to the international community by sharing its unique development experience with other countries.

KOICA has been operating a scholarship program for master's courses in partnership with leading universities in South Korea. With a mission to nurture talented students from developing countries, KOICA has invited high-caliber students from developing countries and helped them gain professional and systematic knowledge that will play a key role in their home country's development. From 1997 to 2014, KOICA Scholarship Program has assisted over 2,150 students through 92 courses. As of 2015, 19 master's degree programs had been running at 19 Korean universities.

The GMPA program was launched in 2011 through the combined effort and dedication of GSPA and the Korea International Cooperation Agency (KOICA) with a mission to nurture talented students from developing countries, particularly in the field of public administration. It is a master's degree program for public officials from developing countries and aims at building public administration capacity and cultivating global leaders who have key competencies and skills required for taking the lead of economic and social development. This program will enable students to grasp widely applicable knowledge and skills through the Korea's development administration and economic development policy, and Korean experiences of economic and social development during their rapid growth period. Since the launch of the program, GMPA has made significant contributions to strengthening the bonds between South Korea and the countries where students come from. The graduates have been applying the knowledge and skills gained from the course, and that has played a crucial role as a bridge between the countries when it comes to their social, political and economic ties. Throughout the program, students will have an opportunity to explore Korea's experiences of overcoming adversity after the war and managing to escape from poverty and to achieve outstanding socio-economic developments.

KOICA Scholarship Program is fully committed to the Sustainable Development Goals (SDGs) and is determined to expand its efforts to nurture future talents from developing countries to promote their sustainable economic growth and social development.

## How to Apply (for KOICA Scholarship Student)

### I. APPLICATION ELIGIBILITY

Prospective applicants must meet all of the following conditions.

1. **Citizenship:** Be a citizen of the Scholarship Program target country.
2. **Government Nomination:** Be officially nominated by their governments.
  - Be a government employee. With a minimum of 2 years of experience in the field of study
  - \* Exception – Applicants with an 'international development NGO' background may apply for the program with two letter of recommendations:
    - Your government office; and
    - Korean Embassy, world widely known NGO, and UN-associated organizations, or the KOICA Organization within your region.
3. **Age:** (Preferable) be under age 40
4. **Health:** Be in good health, both physically and mentally.
  - Those with disabilities, but in good mental and physical health, are eligible to apply.
  - Those with severe illness are NOT ELIGIBLE to apply.
5. **Level of Education:** Have a completed Bachelor Degree or an equivalent to college / university level Educational background.
  - \* Some program have specific qualifications in terms of level of education, and refer to Program Information of each program.
6. **English Proficiency:** Have a good command of both spoken and written English in order to take classes conducted entirely in English and to be able to write academic reports and theses in English.
7. Not be a person who has withdrawn from KOICA's scholarship program.
  - \* Person belonging to the institution in which candidates submitted false documents and returned to his / her country arbitrarily in the middle of SP program cannot apply.
8. Have not participated in KOICA's scholarship program or any of the Korean Government's Scholarship Program before (Master's degree program).
9. and other qualifications from university you are going to apply (refer to the Program Information)

### II. ADMISSIONS PROCESS

#### A. Admission Decision Procedure

- Admission decisions will be made based on overall evaluation of the applications; applicant's academic achievements, potential and personal accomplishments.
- Admission decision procedures consist of
  - Round 1: Evaluation of application package
  - Round 2: On-site essay test and Skype interview
- In the first round, the admission committee reviews a number of factors provided by applicants; academic records, such as Grade Point Average (GPA); study plans; and personal statements, and letters of recommendation.
- In the second round, successful applicants from the first round participate in an essay assessment and Skype interview.
- The first round (evaluation of application package) is worth 50 percent, and the second round (essay test and Skype interview) is also worth 50 percent.

C. Required Documents

All documents should be handed in to the regional KOICA office or the relevant government office.

Your name should match the name on your passport or official certificate of nationality
  - Personal Statement and Study Plan (Form 2)
  - Two Letters of Recommendation (Form 3) from Two Different Professors  
(Recommenders with signature and stamp on the sealed envelope by recommender)
3. Official Bachelor's Certificate of Graduation and Transcript
  - These documents, detailing your academic achievements, are required from every institution that you have attended (excluding the record from primary and secondary schools).
  - Transcripts must provide a record of the course(s) you have taken in each academic year along with final grade(s). If an institution cannot provide a year-by-year record, the school official must at least provide us with a list of the disciplines you have studied.
  - The Apostille or the attachment of an Authentication issued by the Korean Embassy or Consulate, or relevant ministry of applicant's country are NOT necessary during application. (REQUIRED if your admission is confirmed).
  - If there is a record of transfer, the transcript of the previous institute must be submitted. Certificate of Graduation of the previous institute is not necessary.
4. Copy of the Applicant's Passport (or other official document indicating your nationality)
5. Copies of Both Parents' Passports (or other official document indicating parents' nationality)
6. Official document indicating parent-child relationship between the applicant and parents: Applicant's Birth Certificate or Household Register proving the parent-child relationship.
7. Curriculum Vitae
8. Certificate of Employment
9. Proof of English Proficiency: Applicants should submit a score of recognized English proficiency test such as TOEFL, TEPS, IELTS or other supporting documents which demonstrates appropriate English proficiency.

D. Important Notes for All Applicants:

Applicants whose forms and supporting documents are incomplete or insufficient will be disqualified for the admission process.

1. All forms should be **typed in English** and all the supporting documents should be in **English**. Documents in any other language should be accompanied by a notarized translation.
2. Original documents should be submitted. (If it is not unavailable, the originating institution must authorize copies before they are submitted.)
3. If any of the submitted materials contain false information, admission will be rescinded.
4. Applicants should take full responsibility for any disadvantage due to the mistakes or omissions on the application.
5. Make sure you keep photocopies of all completed forms, as all submitted documents will become property of SNU and will not be returned to the applicants.
6. Make sure that, in principle, any modification or cancellation will not be accepted after application has been submitted.
7. We do NOT provide unsuccessful applicants with feedback or reasons for our decisions.

Syllabus

A. Core Courses

Courses	Course Description
<div>Theories of Global Public Administration</div> <div>M2856.000100</div>	This course seeks to introduce students to public administration theories that deal with Western capitalism, socialist nations, communist nations, and the global society. During this course, the distinction between theories of global public administration the development of administration within the developing countries of the 1960s, and the application of relevant theories to the 21st century will be discussed. The course will also explore the administration theories that are appropriate for the global society, as well as global organizations, global leadership, cultivation of global talent, global governance, and global policy.
<div>Theories of Public Policy and Institutions</div> <div>M2856.000500</div>	The aim of this seminar is to introduce major theories of public policy studies in order to deepen our understanding of public affairs. Students are expected to apply the concepts and the theories to real-world public policy challenges. The seminar will analyze policy processes such as agenda setting, policy making, implementation and evaluation. It will also examine various policy actors who influence public policy such as the president, elected politicians, bureaucrats, legal practitioners and civil society activists in addition to ordinary citizens.
<div>Social Research Methods of Public Administration</div> <div>M2856.000300</div>	The course focuses on the comprehensive understanding of research methods for social sciences and limitations of quantitative methods. The course will cover how to set up research questions and hypotheses, collecting data, analyzing and testing data, and report writing. During the course, students will develop research proposals and present in the classroom for further discussion.
<div>Statistical Analysis of Public Administration</div> <div>M2856.000200</div>	The aim of this course is to establish foundations for good analytical inquiries by exploring certain statistical tools that are heavily used in the public policy and public administration analysis. In particular, we are interested in drawing (descriptive or casual) inferences from observed phenomena to unobserved ones by securing the quality of empirical evidence in addition to understanding research questions and describing data. We will cover a wide range of statistical topics and methodological issues based on linear regression model and its variations, and enhance the analytic capability through the series of lab-sessions with statistical packages.

B. Elective Courses

Courses	Course Description
<b>Global Leadership and Public Ethics</b>  M2856.000400	Global leadership must not only promote change and innovation but also act as a form of transformative leadership that pioneers global environmental and social innovation. This course will discuss global leadership and its need within the global society, the qualities of global leadership, social innovation, intellectual development, the need for public ethics, and contents of public ethics.
<b>Public Personnel Administration</b>  M2856.000700	The goal of this course is to examine the major concepts and theories of human resource management (HRM) in the public sector. Based on this knowledge, this course intends to develop students’ professional capacity by analyzing HRM practices and discussing recent cases. The focus of this course is to understand the distinctive features of human resource management in the public sector as compared to HRM in the private sector. The course is organized into three parts: lectures on key concepts and theories, presentation of research by students, and case discussion.
<b>Government and Transparency</b>  M2856.000800	This course introduces the study of corruption and corruption control. The purpose of this course is to understand the topic to systematic study, combining insights from several different disciplinary perspectives, including political science, economics, sociology, and public management.
<b>Organization and Public Administration</b>  M2856.000900	This course intends to help students acquire basic knowledge about organization theories and to develop their ability to think critically about managerial practices in organizations. While some attention will be given to private organizations, the primary focus will be on public and quasi-public organizations. The key themes that will be examined include organizational environment, goals, effectiveness, powers, decision-making, structures, leadership, cultures, and changes. This course will be organized into three sections: lectures on basic concepts and theories, presentation of short paper on assigned readings, and case discussion on team projects.



B. Elective Courses

Courses	Course Description
Central-Local Relations  M2856.001400	Enhancement of local democracy has increased the importance of the inter-communication and coordination between central and local governments and among the local governments. Corresponding with this change, this course looks at topics, such as significance of intergovernmental relations, governmental structures and intergovernmental relations, coordination and cooperation in inter-governmental relations, comparative analysis of IGR, etc.
Economic Analysis  920.620	This course introduces micro-economic concepts and analysis, supply and demand analysis, theories of the firm and individual behavior, competition and monopoly, and welfare economics. Students will also be introduced to the use of micro-economic applications to address problems in current economic policy throughout the semester. The students should have basic knowledge of calculus, and economics.
International Commercial Policy  920.703	This course covers the theory and practice of international commercial policy in some depth. We start by developing a set of simple models of international trade in an effort to understand the re-distributive effects of commercial policy. The course will then add political structure in order to understand the forces that influence the policies chosen by policymakers. We investigate how domestic institutions such as elections, lobbies, and parties influence policy choices. In the next phase, we move from a domestic focus to one that introduces policy-interactions across borders, focusing on the role of international trade-regulating institutions such as the GATT/WTO and their preferential trading arrangements.
Introduction to Government Accounting  920.703	This course provides the fundamentals for Government Accounting and introduces the principles and concepts underlying financial statements. It includes an introduction to the accounting profession, control, concepts, business entities, and all elements of basic financial statements. The course offers an introduction to financial statements and the analyses used by firms to assess financial performance, communicate with various stakeholders, and assess managerial performance. The “user” perspective is emphasized as it is understood that many students who take this course will not pursue accounting as a major.



## Life at Seoul National University

GMPA students attend a variety of school activities such as international seminars, forums, and workshops organized by school or international organizations as well as special lectures by prominent speakers who are experts in government policy and/or development.

These activities are designed to provide high quality extracurricular opportunities for knowledge-sharing and professional development outside the classroom.
